**Appendix n.2 to rector's order n.4/2020  
determining the organization and conditions of work at the  
dormitory at SUA Nitra in the academic year 2020/21**

**Year 2020**

The Rector of the Slovak University of Agriculture in Nitra (hereinafter referred to as the "SUA") issues in accordance with Art. 10 par. 1 of organizational rules of SUA this Appendix no. 2 to the rector's order no. 4/2020, that determines the organization and conditions of work at dormitory at SUA in Nitra in the academic year 2020/2021 (hereinafter referred to as the "Rector's order").

**Appendix n.1 to rector's order n.4/2020 is amended as follows:**

1. I am cancelling the schedule of accommodation check-in during the period **from October 2, 2020 till October 4, 2020**, due to the distance form of education in the winter semester of the academic year 2020/2021.
2. I am issuing following instructions for accommodation at ŠDaJ:
  - a. all accommodated students who have paid for the accommodation from September till December will be fully reimbursed by November 15, 2020 (except for students who are already accommodated),
  - b. accommodation for students of I. and II. level of study will be provided only in the case of practice, preparation of thesis or group education, and the choice of selected names will be based on the list of names that will be sent by the faculty to the accommodation department of ŠDaJ,
  - c. individual accommodation apart from exceptions referred to in 2b. will not be allowed,
  - d. payment for accommodation in cases mentioned in 2b. will be done according to instructions sent to the student by the accommodation department of ŠDaJ,
  - e. accommodation in cases mentioned in 2b. is short-term accommodation for the time necessary for the implementation of practice, group education or preparation of thesis,
  - f. during short-term accommodation in cases mentioned in 2b, students will be allowed to eat in the canteen of ŠD Anton Bernolák,
  - g. in the case of renewal of the full-time form of education, students will have to re-apply for accommodation and pre-register via UIS.
3. For students III. level of study, the existing regulations remain in force.
4. Foreign students are accommodated in accordance with Appendix n.1 to rector's order n.4/2020
5. Accommodation for already accommodated foreign students is not canceled, they can stay accommodated at ŠDaJ even during the distance form of education.
6. Due to the rationalization of operations of ŠDaJ, the management of the ŠDaJ may order the transfer of the student to another accommodation facility of the SUA in Nitra.

**Final provisions**

Appendix n.2 to rector's order n.4/2020 shall enter into force and effect on October 1<sup>st</sup>, 2020  
Other provisions of the Rector's Order no. 4/2020 remain in force without change.
